### I. PRINCIPAL'S REPORT

- Burnaby Board of Education has implemented the expanded mask mandate as of Monday, Oct 4, requiring students in Kindergarten through Grade 3 to wear face masks at school. By speaking with the primary teachers, we know that most of our primary students have always been wearing masks even prior to this mandate taking effect.
- We did have another positive COVID case since our last PAC meeting. Fraser Health has deemed that there was no self-isolation requirement. The class did receive a notification.
- We will go ahead with the recorders for music class.

### II. HEAD TEACHER'S REPORT

- We had our Terry Fox run on Oct 1, and we raised \$399 altogether this year.

- Reviewing air purifier options. For 22 classrooms we will be looking at around \$7000 total cost. Candidates we looked at: Grem Guardian AC5350 – has a HEPA filter and UV light sanitizer at around \$180 and Honeywell with HEPA filter at around \$330 that covers more sq. footage.
